

Privacy Policy

This Privacy Policy explains how information is handled through vatra.vc. Vatra is an initiative of Solten Ventures LLC; references to Vatra, we, us, or our mean Solten Ventures LLC in connection with this initiative.

1. Information We May Collect

We collect information you choose to provide and limited information generated when you interact with the website.

- Contact information, such as name, organization, role, email address, and other contact details.
- Communications, including messages, meeting requests, and correspondence.
- Founder or company information submitted through forms or other channels.
- Technical information, such as device and browser information, IP address, referral information, and basic website usage data.
- Information received from professional contacts, public sources, event interactions, or service providers where permitted by law.

2. How We Use Information

Retention periods vary depending on the nature and context of the information.

We use reasonable administrative, technical, and organizational measures appropriate to the nature of the information we handle. No internet transmission or storage system can be guaranteed to be completely secure.

8. Your Privacy Choices and Rights

Depending on where you live and applicable law, you may have rights to request access to, correction of, or deletion of certain personal information, or to object to or restrict certain processing. You may also withdraw consent where processing is based on consent.

California and other U.S. state residents may have additional rights under applicable state privacy laws. We will evaluate verified requests under the law that applies to us and to the request. We will not discriminate against you for exercising an applicable privacy right.

9. International Visitors
